

**STRATEGI KEPOLISIAN DALAM MELAKSANAKAN PENCEGAHAN
GANGGUAN KEAMANAN DAN KETERTIBAN MASYARAKAT DI
MASA PANDEMI COVID-19.**

Pandemi Covid-19 saat ini telah menyebabkan berbagai dampak aspek dalam kehidupan manusia salah satunya terjadinya peningkatan gangguan Kamtibmas. Kepolisian dalam hal ini Sat Intelkam Polres OKU sebagai lini terdepan dalam pencegahan gangguan Kamtibmas telah melaksanakan berbagai upaya dalam mencegah timbulnya gangguan Kamtibmas.

Penelitian menggunakan metode kualitatif lapangan. Jumlah Informan sebanyak 5 Orang ditentukan dengan teknik *Purposive Sampling*. Teknik pengumpulan data yang digunakan yaitu Observasi, Wawancara dan Dokumentasi. Dalam penelitian ini, penelitian menggunakan empat variabel Strategi Publik Model Mulgan (Progresif) yaitu tujuan (*purposes*), lingkungan (*environment*), pengarahan (*directions*) dan aksi (*actions*).

Pada variabel tujuan, Sat Intelkam telah menyusun Strategi yang selanjutnya di implementasikan melalui berbagai kegiatan preemtif dan preventif. Pada bidang pengarahan, Sat Intelkam menerapkan teori komunikasi Organisasi, memberikan *Reward* dan *Punishment* kepada personil serta menggunakan Kegiatan Cofee Break untuk mendekati diri kepada personil. Pada bidang Lingkungan, Sat Intelkam menggunakan kegiatan penyelidikan terbuka dan tertutup untuk pengamatan situasi lapangan. Pada bidang Aksi, jumlah SDM yang dimiliki Sat Intelkam sebanyak 42 Personil belum sesuai dengan kebutuhan. Mengenai Faktor pendukung yaitu adanya dukungan dari Pimpinan Polri yang mengeluarkan beberapa produk hukum yang menjadi pedoman anggota serta dukungan anggaran yang diberikan dalam menunjang kegiatan di lapangan. Mengenai Faktor Penghambat terletak pada jumlah SDM tidak sesuai dengan kebutuhan dan juga sarana dan prasarana belum cukup memadai sesuai kebutuhan.

Dari hasil Penelitian, penulis menyarankan agar Kapolres OKU menambah jumlah personel Sat Intelkam Polres OKU dilapangan serta meningkatkan Kerja sama dengan unsur stakeholder yang ada di Kab. OKU dalam rangka mewujudkan kondusifitas di wilayah Kab. OKU.

ABSTRACT

POLICE STRATEGY IN CARRYING OUT THE PREVENTION OF SECURITY AND PUBLIC ORDER DISTURBANCES DURING THE COVID-19 PANDEMIC.

The current Covid-19 pandemic has caused various aspects of human life, one of which is the increase in Kamtibmas disorder. The police in this case Sat Intelkam Polres OKU as the front line in the prevention of Kamtibmas disorder has carried out various efforts in preventing the onset of Kamtibmas disorder.

Research uses qualitative field methods. The number of informants as many as 5 people is determined by purposive sampling techniques. The data collection techniques used are Observation, Interview and Documentation. In this study, the study used four variables of mulgan model public strategy (progressive) namely purposes, environment, directions and actions.

In the objective variable, Sat Intelkam has devised a strategy that is further implemented through various preemptive and preventive activities. In the field of direction, Sat Intelkam applies organizational communication theory, provides Rewards and Punishments to personnel and uses Cofee Break Activities to get closer to personnel. In the field of Environment, Sat Intelkam uses open and closed investigation activities for observation of field situations. In the field of Action, the number of human resources owned by Sat Intelkam as many as 42 personel has not been in accordance with the needs. Regarding the supporting factor, there is support from the Police Leadership who issued several legal products that became member guidelines and budget support provided in supporting activities in the field. Regarding the Inhibitory Factor lies in the number of human resources not in accordance with the needs and also the facilities and infrastructure are not adequate enough as needed.

From the results of the research, the author suggested that the OKU Police Chief increase the number of personnel of the OKU Police Intelligence Sat on the ground and increase cooperation with stakeholders in kab. OKU in order to realize conduciveness in the area of Kab. OKU.
